⁶ The ICRP has developed another clearance classification with its ICRP-66 respiratory tract model for radiation dosimetry, which defines the type of material inhaled [Type F is deposited material that is readily absorbed into blood from the respiratory tract (fast solubilization); Type M has an intermediate rate of absorption (moderate solubilization), and Type S is insoluble in the respiratory tract (slow solubilization)]. The fractional absorption of a Type M material from the respiratory tract is intermediate between that of ICRP-30 Classes Y and W material, and the fractional absorption of Type S is substantially less than that of ICRP-30 Class Y.
