QUALITY REVIEW OF HEALTH EXAMINATION PROGRAM

Persian Gulf Registry Health Examination Program Quality Management/Self Assessment Monitor Pilot Test - Washington VAMC; May 24-25, 1995

### Summary Analysis of Pilot Self Assessment Monitor Results:

A. Background: The medical records reviewed for the pilot study were chosen by Washington VAMC Medical Records personnel from a list of veterans who had received a Persian Gulf Registry Health Examination. The most physically accessible charts were collected for the reviewers. The Self-Assessment Monitor is provided in Attachment A.

N = 78 (72 Male, 6 Female) - The total number of Persian Gulf Registry Health Examinations completed at Washington VAMC as of MAY 25, 1995 is 873 (9% sample).

- B. Standard Registry Exam:
- 1) Code Sheets: 75 of 78 charts contained Code Sheets (4% non-compliance)
- 2) History and Physical (SF88): 70 of 78 charts contained an SF88 (10% non-compliance)
- 3) CBC: 74 of 78 charts contained CBC test results (5% non-compliance)
- 4) <u>Chemistries</u>: 74 of 78 charts contained Chemistries (5% non-compliance)
- 5) <u>Urinalysis</u>: 72 of 78 charts contained Urinalysis (7% non-compliance)
- 6) Chest x-ray: 53 of 78 charts contained Chest x-ray results (32% non-compliance)
- a. Of the 25 charts that were missing Chest x-ray results, 4 included follow-up letters indicating Chest x-rays were completed. One patient failed to show up for his appointment.
- 7) Follow-up Visit: 8 of 78 charts recorded a Follow-up Visit (92% non-compliance)
- 8) Follow-up Letter: 74 of 78 charts included a Follow-up Letter (5% non-compliance)

- C. Work-up For Common Complaints:
- 9) Patient Complaint Persistent Diarrhea: 71 of 78 charts were N/A
- a. Of the 7 "applicable" cases, 6 charts did not show that any of the Persistent Diarrhea procedures were completed; while one chart did show completion (86% non-compliance).
- 10) Memory Loss: 65 of 78 charts were N/A
- a. In one of 13 "applicable" cases where the patient complained of memory loss a CT and Neurology consult were completed, and in one case a Neurology consult was recommended, but not scheduled or completed (85% non-compliance).
- 11) Shortness of Breath/Chronic Cough: 69 of 78 charts were N/A
- a. Of the 9 "applicable" cases, 5 charts showed additional diagnostic procedures, i.e., Lung Exam, Pulmonary Function Test, Smoking History (44% non-compliance).
- 12) Follow-up Appointment Scheduled: 41 of 78 were N/A
  - a. 13 of 37 "applicable" cases showed a scheduled follow-up exam scheduled
- b. 20 of 37 "applicable" cases showed no follow-up exam scheduled (54% non-compliance)
  - c. In 4 cases, the reviewer did not enter a code
- D. Primary Care Team Assignment: 35 of 78 were N/A
- a. Of the 43 "applicable" cases each veteran who has been given a Registry examination receives a Primary Care Team Assignment. This information is not recorded in the patient chart, but is accessible by computer. The assignment is not recorded in the patient chart until the patient visits a clinic (0% non-compliance).




#### Background/Purpose:

#### Reminders


- 1) All women Persian Gulf veterans should be offered a breast examination and Pap smear.

- 4) Subsequent reviews should be conducted on an annual basis hereafter, with results submitted to Environmental Agents Service (EAS) by October 1st of each year.


